<p>FISCAL COMMITTEE – which shall assist with the development of strategies to secure additional funding for the Commission and regularly review quarterly expenditures.</p> <p>Meetings are held in the first month of each quarter (Jan, April, July, and October) on the first Wednesday at 2pm as needed.</p> <p>Please note: The Fiscal Committee met on April 9th at 2pm.</p>	<p>PERSONNEL COMMITTEE – which shall be composed of the Chairperson and Commission officers to address personnel policy and all other matters related to the Commission.</p> <p>Meetings are held in the second month of each quarter (February, May, August, and November) on the 1st Tuesday at 2pm as needed.</p>
<p>LEGISLATIVE COMMITTEE – which shall review health legislation and make recommendations to the Board.</p> <p>Meetings are held quarterly at a time to be scheduled at the convenience of the legislators as needed.</p>	<p>NOMINATION COMMITTEE – which shall be initiated annual for the purpose of the election of officers and recruitment of committee members.</p> <p>Meetings will be held as scheduled: 10/15/14 @ 3pm, 11/5/14 @ 3pm, 1/16/15 @ 8:15 am</p>
